ALTERATIONS AND CANCELLATION POLICY

Alterations

Alterations may be made to any existing reservation. Alterations via the Internet up to 2 days before start date are free of charge. Alterations made at selected DOC offices will incur a \$10 fee.

Cancellations (Special Circumstances)

If the Department of Conservation closes a service due to severe weather or track conditions, a full refund will be given on the unused services. Those visitors already on a track may be required to exit the track. Cancelled groups will be able to depart only if there are vacancies available once the service reopens.

Cancellations

If visitors cancel their bookings the following cancellation fees apply, based on the earliest start date (i.e. date before any alterations are made to the booking):

Cancellation fees are based on the earliest start date $*$	Cancellation Fee
Cancenation lees are based on the earliest start date	
More than 10 days before the start date and within 48 hours of making the booking	0%
More than 10 days before the start date and more than 48 hours after making the booking	25%
Between 3 and 10 days before the start date	50%
Between 1 and 2 days before the start date	100%
On or after the start date	100%
Medical circumstances that prevent customer walking track - must be accompanied by medical certificate	20%
Booked Transport	0%

*Note: Fees charged are calculated from the original booking start date or if the booking has been transferred to an earlier date, fees will be calculated from the earlier date.

Transfers

Administration fees may apply if a transfer is made 2 days or less before the start date. Such transfers must be done by a DOC Office. **Travel Insurance**

The Department of Conservation recommends that you arrange travel insurance to guard against the loss of costs associated with cancellation or delay of your trip. The Department of Conservation will not be liable for injury, damage or any costs incurred by intending visitors and is unable to rearrange transport and accommodation bookings if delays should occur.

Credit Card Details

If you need a DOC Office to make an alteration, transfer or cancellation, you must therefore phone or fax your credit card details again using the contact address below.
